



From January 1 through June 30, 2022, 9 bus replacement projects and associated scrapping were completed and reimbursed, with the remaining projects anticipated for completion within CY2023. As of June 30, 2022, a total of 53 bus replacement projects and associated scrapping have been completed and reimbursed.</p>
