### <u>Technical Assistance Program in the VW Settlement Environmental Mitigation Trust</u> <u>Agreement for Indian Tribe Beneficiaries</u>

As per 2.1.1.4 of the Environmental Mitigation Trust Agreement for Indian Tribe Beneficiaries (the "Indian Tribe Trust Agreement") filed with the U.S. District Court for the Northern District of California on September 6, 2017 (Case 3:16-cv-00295-CRB), Northern Arizona University's Institute for Tribal Environmental Professionals (ITEP) submits the following as the first semi-annual report. This report provides an overview of the progress of technical assistance activities provided by ITEP for the period of October 1 – December 31, 2017 (the "reporting period") in support of the Volkswagen Diesel Emissions Environmental Mitigation Trust for Indian Tribe Beneficiaries (the "Indian Tribe Trust"). This report includes a complete description of the status, development, and implementation of the services. The report should be reviewed in conjunction with the Trustee-approved, first-year ITEP budget (the "first-year budget") for the period October 2017 – September 2018, which is available at https://www.vwenvironmentalmitigationtrust.com/tribe-trust.

#### **Summary**

ITEP's Scope of Work to provide technical assistance to all federally-recognized tribes seeking to access the Indian Tribe Trust began on October 1, 2017. Specific project tasks for ITEP consist of the following tasks:

- 1. One-on-One Technical Assistance
- 2. Web-based Outreach and Education
- 3. Monthly Webinars
- 4. In-Person Trainings

### Task 1: One-on-One Technical Assistance

ITEP staff provided email and phone-based technical assistance to tribes contacting ITEP directly. During the reporting period, ITEP made 132 separate contacts with 84 tribes with tribes seeking information or requesting technical assistance. By the close of the reporting period, approximately 30 tribes had commenced the process to become Designated Beneficiaries of the Indian Tribe Trust. The deadline for filing the Certification for Beneficiary Status under Environmental Mitigation Trust Agreement (Appendix D-3) for the first round of funding is January 2, 2018. With the help of ITEP's one-on-one technical assistance, approximately 30 tribes also began the process to submit to the Trustee a Beneficiary Eligible Mitigation Action Certification (Appendix D-4). The deadline for filing the Appendix D-4 for the first round of funding is also January 2, 2018.

# Task 2: Web-based Outreach and Education

ITEP staff created a public-facing website for ITEP's VW Settlement Technical Assistance Program (<u>https://www7.nau.edu/itep/main/volkswagensettlement/</u>) and posted fact sheets, court documents and fillable forms for tribes to use. Training materials like recorded webinars, videos, and presentations were posted to the site. In addition, monthly notifications announcing upcoming calls, as well as providing notice of important Trust-related actions and timelines were sent out to 3,500 people currently listed in the ITEP database that have email addresses that are affiliated with a tribe, tribal office and/or tribal agency.

### Task 3: Monthly Webinars

- Development of webinars providing instruction and guidance on the application process
- Presentations at regional tribal environmental conferences
- 8-hour in-person training at the National Tribal Forum on Air Quality (May 14, 2018)
- In-person presentation to the Alaska Forum on the Environment (February 15, 2018)
- Development of fact-sheets and brochures to federally recognized tribes
- Planning and development of the Tribal Advisory Council
- Hire additional project staff and contract support to further enhance administrative and technical support services

ITEP will also continue to seek feedback and comments from tribes on how to improve its services to better meet the training and technical assistance needs of tribes.
