As per 2.1.1.5 of the Modified Environmental Mitigation Trust Agreement for Indian Tribe Beneficiaries (the "Indian Tribe Trust Agreement") filed with the U.S. District Court for the Northern District of California on November 15, 2018 (Case 3:15-md-02672-CRB), Northern Arizona University's Institute for Tribal Environmental Professionals (ITEP) submits the following semi-annual report. This report provides an overview of the progress of technical assistance activities provided by ITEP for the period of January 1 – June 30, 2019 (the "reporting period") in support of the Volkswagen Diesel Emissions Environmental Mitigation Trust for Indian Tribe Beneficiaries (the "Indian Tribe Trust").

Summary

ITEP's Scope of Work to provide technical assistance to all federally-recognized tribes seeking to access the Indian Tribe Trust began on October 1, 2017.

Specific project tasks for ITEP consist of the following:

- 1. One-on-One Technical Assistance
- 2. Web-based Outreach and Education
- 3. Webinars
- 4. In-Person Trainings
- 5. Establishment of Tribal Advisory Council

Task 1: One-on-One Technical Assistance

ITEP staff provided email and phone-based technical assistance to tribes contacting ITEP directly. During the reporting period, ITEP focused its technical assistance efforts primarily into the two following categories: 1) Tribes designated as beneficiaries for the first funding cycle

under the Indian Tribe Trust Agreement ("first funding cycle"); and 2) Tribes interested in becoming beneficiaries for the second and future funding cycles under the Indian Tribe Trust Agreement ("second and future funding cycles").

Technical assistance for First Funding Cycle: Technical assistance was provided to the 26 previously designated beneficiaries that were able to submit funding requests for the first funding cycle. One Tribe chose to opt out of the first funding cycle, but the other 25 submitted funding requests, and ITEP assisted them through email and phone conversations as needed.

Technical Assistance for Second and Future Funding Cycles: The second funding cycle was announced on January 15th, 2019, and as ITEP began outreach efforts to inform Tribes of the availability of VW Settlement funding, a large number of Tribes contacted ITEP for one-on-one technical assistance. ITEP worked directly with tribal staff holding conference calls, reviewing vehicles and equipment eligibility, and providing instructions on the Beneficiary Incumbency process, to help them prepare for the second funding cycle. In all ITEP worked with 68 Tribes seeking technical assistance. On May 17, 2019, 41 Tribes were designated as new Beneficiaries of the Tribal Trust, and many of the remaining Tribes who worked with ITEP will likely participate in the Trust in future funding cycles. A complete listing of Tribes seeking technical assistance from ITEP is provided in Table 1.0 below.

Task 2: Web-based Outreach and Education

ITEP's VW Settlement Technical Assistance Program website (https://nau.edu/itep-vw) was kept updated with new information and resources during the reporting period. During this reporting period ITEP staff made significant changes to the website, adding additional content on the process of becoming a beneficiary and seeking funds from the Tribal Trust, as well as how to participate in the Tribal Advisory Council. Other portions of the site were also revised to provide a more streamlined, user-friendly experience for Tribes seeking information. Training materials such as recorded webinars, videos, and presentations continued to be maintained. The table below provides details of website traffic for the reporting period.

Task 3: Webinars

During this reporting period ITEP conducted outreach and training to Tribes through periodic webinars. Timed to coincide with new developments or deadlines for the first and second funding cycles, ITEP used these webinars to present information on the overall process of becoming a Beneficiary of and seeking funds from the Tribal Trust, instruct Tribes in the requirements of specific forms and attachments to be submitted at various points in the process, and remind Tribes of upcoming deadlines.

ITEP staff also organized several calls for Alaskan Native Tribes and participated in conference calls and webinars of tribal organizations such as the National Tribal Air Association (NTAA) to provide updates related to the Trust Agreement and ITEP's technical assistance efforts. A summary of the webinars / calls ITEP staff participated in is provided below.

Task 4: In-Person Trainings & Outreach Events

ITEP staff conducted one in-person training for 14 attendees during the reporting period. This trainings was held in Flagstaff, Arizona as part of a broader air quality training course. In addition to this training, a presentation was given and an outreach table was set up at a national conference on air quality to provide tribes with information about the VW Settlement and collect contact information to add to ITEP's growing contact list for outreach purposes. Task 5: Establishment of Tribal Advisory Council

As part of the Modified Trust Agreement, ITEP was tasked with establishing a Tribal Advisory Council (TAC). The purpose of the TAC is to advise the technical assistance provider (ITEP) on its outreach and training efforts to ensure that Indian Tribes are aware of the Indian Tribe Trust, and to provide a forum for Indian Tribes to raise general questions relating to the Indian Tribe Trust Agreement.

In March, 2019, ITEP solicited applications for membership in the TAC, and in April the TAC was formally established with seven members from Tribes across the country, including Alaska. Members of the TAC are listed below.

The TAC held its first meeting on May 31st, 2019, and plans to meet monthly for the next six months or so through the second funding cycle, to address questions from Tribes as they come up and provide feedback to ITEP and the Trustee about the process.

Continuing Work and Future Activities

ITEP will continue to provide outreach, training and technical assistance to tribes interested in becoming beneficiaries of the Volkswagen Environmental Mitigation Trust Agreement for Indian Tribe Beneficiaries. Future activities will include, but not be limited to, the following:

- Development of webinars providing instruction and guidance on the application process
- Outreach at the Tribal Lands and Environment Forum, Palm Springs, CA August 2019
- Outreach at Alaska Tribal Conference on Environmental Management, Anchorage, AK November, 2019
- Work one-on-one with tribal beneficiaries to review and assist with submission of Appendix D-4 forms for the second funding cycle
- Continued support of and work with the Tribal Advisory Council
- Hire additional project staff and contract support as necessary to enhance technical support services

ITEP will also continue to seek feedback and comments from tribes on how to improve its services to better meet the training and technical assistance needs of tribes.
