<u>Trustee Descriptive Report for Period January 1, 2019 to June 30, 2019</u> *As required under subparagraphs 3.3.1.6 and 3.3.1.7*

Establishment, Purpose, and Funding of the State Trust

On October 25, 2016, Volkswagen AG ("VW") and certain subsidiaries entered into a Partial Consent Decree, and on May 17, 2017 entered into a Second Partial Consent Decree, in the United States District Court, Northern District of California (the "Court"), which required VW to make payments in the amounts of \$2.7 billion and \$225 million, respectively, to fulfill their environmental mitigation obligations pursuant to the Decrees. The Decrees required the Settling Defendants to establish the Environmental Mitigation Trust State Beneficiaries, Puerto Rico, and the District of Columbia (the "State Trust" or "State Mitigation Trust") and to fund the State Trust with funds to be used for environmental mitigation projects that reduce emissions of nitrogen oxides ("NOx") where the Subject Vehicles were, are, or will be operated ("Eligible Mitigation Actions"), and to pay for Trust Administration Costs as set forth in the trust agreement of the State Trust (the "Trust Agreement").

On March 15, 2017, the Court appointed Wilmington Trust, N.A. ("WTNA") as the Trustee for the State Mitigation Trust (the "Trustee"). The State Trust's purpose is to fund eligible environmental mitigation projects that reduce emissions of nitrogen oxide. The State Trust also provides for the payment of Trust Administration costs. On October 2, 2017, the State Trust was established and approximately \$1.99 billion was deposited into the Trust before the end of 2017.

By the end of 2018, the Trustee received from the Settling Defendants a deposit of approximately \$882 million, which represented the State Trust's portion of the final \$900 million required under the 2.0L Partial Consent Decree. In accordance with the Trust Agreement, the Trustee allocated these funds to each State Trust Beneficiary consistent with the weighted average allocation rates set forth in Appendix D-1B. With this funding, the State Trust was considered fully funded at the start of this reporting period.

In the reporting period (January 1, 2019 to June 30, 2019), the Trustee completed a number of actions required under the Trust Agreement and Consent Decrees, which included receipt and review of Beneficiary Eligible Mitigation Action Certification forms from a number of States; disbursement of funds under a number of approved Eligible Mitigation Action (EMA) requests; minor modifications to the Trust Agreement; receipt of the Private Letter Ruling from the IRS; and, payment of Trust bills. A brief description of each of these actions is included below.

3.3.1.7 Actions taken in reporting period in accordance with Trust Agreement and Consent Decrees

Receipt and Approval of Beneficiary Eligible Mitigation Action Certification (Appendix D-4) Forms

In the period, the Trustee received and reviewed Beneficiary Eligible Mitigation Action Certification (Appendix D-4) Forms submitted for approval¹ from the States of Arizona, Arkansas, California, Colorado, Delaware, Georgia, Hawaii, Idaho, Illinois, Iowa, Louisiana, Maine, Minnesota, Missouri, Nebraska, Nevada, New Hampshire, New Jersey, North Carolina, Ohio, Oklahoma, Oregon,

Pennsylvania, South Dakota, Texas, Vermont, Virginia, and Washington. Although many of the Eligible Mitigation Action Certification (Appendix D-4) Forms have been approved, not all of the Beneficiaries have requested receipt of trust funds during this period.

Of the \$376.7 million in budgeted Appendix D-4 submissions that it approved, the Trustee disbursed approximately \$74.3 million as requested by State Beneficiaries to fund the approved Eligible Mitigation Actions of the detailed in Table 1. The remaining approximately \$300 million in budgeted Appendix D-4 funds approved, but not disbursed, are reflected as an accrued payable in the financial statements for the period ending June 30, 2018.

Minor Modifications to the State Trust

During the Trustee's pursuit of the Private Letter Ruling ("PLR") from the Internal Revenue Service ("IRS") as required by paragraph 6.7 of the Trust Agreement, the IRS advised the Trustee that amending the final liquidation provision in subparagraph 5.4.5 of the Trust Agreement to clarify that the entirety of the final liquidation would be paid to the Beneficiaries would expedite receipt of the ruling (contemplated by paragraph 6.7 of the Trust Agreement) confirming that investment income earned on the Trust Assets is excludible from gross income. After conferring with the United States and Beneficiaries of the Trust, the Trustee then proposed minor modifications to the Trust Agreement in order to preserve Trust Assets and ensure the final liquidation distribution goes entirely to the Beneficiaries

(such modifications, collectively, the "Minor Modifications"). The Trustee believed that this modification was consistent with the purpose of the Trust, which is intended to fund Eligible Mitigation Projects proposed by the Beneficiaries. In addition, the Minor Modifications to the Trust Agreement also included certain conforming and clarifying changes.

On March 13, 2019, the United States filed a Notice of Motion with the Court that included (i) a marked version of the Trust Agreement showing the Minor Modifications from the Trust Agreement which was filed on October 2, 2017 at Dkt 51-1 with the Court in the case *United States of America v. Volkswagen AG et al* case number 3:16-cv-00295-CRB And (ii) a clean version of the Trust Agreement incorporating the Minor Modifications together with all exhibits. A clean version of the Trust Agreement incorporating the Minor Modifications together with all exhibits can be found at Dkt 79 with the Court in case *United States of America v. Volkswagen AG et al* case number 3:16-cv-00295-CRB and at Dkt 5999 in *In re: Volkswagen "Clean Diesel" Marketing, Sales Practices, and Products Liability Litigation* case number 3:15-md-02672-CRB.

In accordance with paragraph 6.5 of the Trust Agreement, the Minor Modifications to the Trust Agreement became effective on April 12, 2019, which is known as the "Trust Modification Effective Date."

Receipt of Private Letter Ruling from the Internal Revenue Service

On April 15, 2019, the Trustee received the PLR from the IRS confirming (i) that the State Trust will be treated as a Qualified Settlement Fund under 26 C.F.R. § 1.468B-1 and (ii) that all investment income earned on the Trust Assets will be excludible from gross income under Section 115 of the Internal Revenue Code, 26 U.S.C. § 115, in each case as required by Paragraph 6.7 of the Trust Agreement. Such PLR also confirms that the State Trust may exclude from its gross income, under 26 C.F.R. § 1.4688—2(b)(1), the amount of certain funds transferred to the State Trust after its establishment as a Qualified Settlement Fund.

Return of Funds to State Allocation Accounts and Taxes

Subparagraph 2.1.5.1 of the Trust Agreement requires that "within 30 Days of receipt of a Private Letter Ruling from the IRS determining that all investment income earned on the Trust Assets is excludible from gross income under Section 115 of the Internal Revenue Code, 26 U.S.C. § 115, the Trustee shall allocate all amounts held in the Tax Payment Subaccount to the Beneficiaries, consistent with the allocation rates included in Appendix D-1 B."

On May 15 the Trustee began an orderly return of all funds on deposit in the Tax Payment Subaccount that were not necessary for the payment of any Federal or State Taxes. The Trustee has been working to complete this process as promptly as practicable.

In light off the favorable conclusions within the IRS PLR, the State Trust will no longer make quarterly, estimated federal income tax payments. As of June 30, 2019, the Trustee was continuing to work with its tax advisors and the IRS to file amended federal income tax returns to obtain a refund of all federal

income taxes paid while the PLR was pending. The Trustee will be allocating tax refunds from the IRS back to the Beneficiaries in accordance with the allocation rates included in Appendix D-1 B when they are returned to Trustee by the IRS and will then resume the allocation of investment income pursuant to subparagraph 3.2.3.

Additionally, the Trustee is in the process of obtaining confirmatory rulings and/or statements from the States of Delaware and California tax authorities that they will treat the State Trust in the same manner as described in the IRS PLR. Consistent with the positions taken during the pendency of the IRS PLR request, the Trustee will continue to hold sufficient funds in the Tax Payment Subaccount to pay any Delaware and California state taxes until the confirmation by those states as to the tax-free status of the Trust is obtained. Currently, there are sufficient funds in the Tax Payment Subaccount to pay State Taxes and thus the Trustee does not anticipate a need for any additional withholding of investment income, although the Trustee reserves its right set forth in the Trust Agreement to do so should we not receive a favorable ruling and/or statement from Delaware and California.

Payment of Trust Bills

In the period, the State Trust paid \$456,107 in Trust Administration Costs. The State Trust also paid approximately \$373,601 in costs to third-party professionals.
