## Description of Status (include actual or projected termination date):

EMA 1 - Replacement of class 7 septic truck. The vehicle is currently being built at the manufacturer with an estimated completion date of early December, 2019. Once complete, the tank will be manufactured and installed locally. Projected termination date is the first week of February, 2020.

EMA 2 - Replacement of a class 7 school bus. The school bus is in the final stages of completion and will be delivered in early December, 2019. Projected termination date is the second week of December, 2019.

#### Development (planning work accomplished for the project):

Price quotes for both EMAs were obtained and subsequently approved by the Pueblo of Isleta Procurement Department in accordance with the Pueblo's purchasing policies.

EMA 1 – July 12, 2019, updated quote received from vendor and approved by Procurement Department.

EMA 2 – Pricing quote validated by vendor on August 29, 2019 and approved by Procurement Department.

EMA 1 - Purchase order for the vehicle was released to contractor on July 16, 2019.

EMA 2 – Purchase order for the school bus was released to contractor on August 30, 2019.
