- 6) Bi-annual reports as required by the Trustee or the Court in accordance with Tribal policy

No confidential or personally identifiable information will be posted in any public notification from the Tribe pursuant to Tribal and Federal policies. All tribal laws regarding publicly available documentation requirements and policies will be followed.

As outlined above, the D-3, D-4, reports, and all documentation pertaining to the EMA projects will be available to the public. Contact information for the Public Works Director, Keith Gove, from the Public Works Department (Lead Agency) will be posted on the website listing for any community members who have questions or request documentation pertaining to the EMA project of information pertaining to the Mitigation Settlement.

MPTN will maintain and make publicly available all documentation submitted in support of the funding request, as well as records supporting all expenditures of EMA funds, subject to approved MPTN Tribal policies, procedures and law. No confidential or personally identifiable information will be posted in any public notification from the Tribe pursuant to Tribal and Federal policies. All tribal laws regarding publicly available documentation requirements and policies will be followed.

Any questions regarding documents posted for public participation will be directed to the Lead Agency, MPTN Public Works Department to the MPTN Public Works Director. The public will be allowed to submit questions directly to the Public Works Director via email or will be

able to call the Public Works Department to talk to the Public Works Director directly. Public Works will endeavor to answer public inquiries immediately but no later than 7 days. If copies of documents are requested Public Works will provide the individuals' copies of all requested documents in the earliest manner possible.

- Bi-annual reporting on MPTN's EMA implementation will be posted no more than 30 days after the end of each reporting period. MPTN anticipates an approved award of funds on November 13, 2019. MPTN will complete the project by 8/30/2020. The first semi-annual report will be due by May 13, 2020. Both this report and the Final Report will be submitted to the Trustee via Intralinks through the 1) the MPTN Grants Administrator, 2) the MPTN Finance Controller, or 3) the MPTN Public Works Director; all of whom have been identified, designated, and approved through the Trustee's Incumbency Certificate and as approved by the MPTN Tribal Chairman as authorized users and submitters in the Intralinks System.
- MPTN understand that for each EMA, MPTN shall submit a comprehensive Final Report to the Trustee (via Intralinks) describing the progress made on implementing each EMA covering the first funding award term. This report shall include a summary of all costs expended on the EMA through the reporting date and will be due by November 13, 2020.
- These reports will include a complete description of the status (including actual or projected termination date), development, implementation, staff involved and duties, and any modifications to each approved EMA. MPTN will group multiple EMA's into one report. These reports will be signed by an official with the authority to submit the report for MPTN.

Mashantucket Pequot Tribal Nation will oversee the proposed EMAs as follows:

• Mashantucket Pequot Tribal Nation will review and programmatic and financial expenditures of its EMAs to ensure compliance with Mitigation Settlement policies and Wilmington Trust's requirements as well as applicable Tribal policies and procedures. Programmatic Compliance will be conducted by MPTN's Public Works Department (Lead Agency), MPTN's Compliance Officer and in coordination with the MPTN Grants Administrator. Financial Reporting will be conducted by MPTN Finance Department in coordination with the MPTN Compliance Officer and MPTN Grants Administrator. Outlined below are our Standards for Financial Management. Mashantucket uses these standards for all organizational and grant/contract financial agreements, procurement practices, and property management.

MPTN Financial Management Standards

Mashantucket Pequot Tribal Nation by Tribal Council Resolution TCR032807-05 adopted the MPTN Standards for Tribal Organization Management Systems for submission to the Federal agencies to meet the requirements under 25 CFR, chapter V, Part 900, Subpart F. The standards are:

- Sections: A. Standards for Financial Management System
 - B. Standards for Procurement Management System
 - C. Standards for Property Management System

A. Standards for Financial Management System

The Mashantucket Pequot Tribal Nation (MPTN) shall expend and account for contract funds in accordance with all applicable tribal laws, regulations, and procedures in carrying out a self-determination contract.

The MPTN fiscal control and accounting procedures are sufficient to:

- a) Permit preparation of reports required by a self-determination contract and the Act; and
- b) Permit the tracing of contract funds to a level of expenditure adequate to establish that they have not been used in violation of any restrictions or prohibitions contained in any statute that applies to the self-determination contract.

MPTN Requirements to meet the required Financial Management System Standards are as follows:

- a) MPTN's Department of Finance will provide the Secretary a completed Financial Status Report, SF 269, as negotiated and agreed to in the self-determination contract.
- b) MPTN's Department of Finance shall maintain financial records sufficiently detailed to identify the source and application of self-determination contract funds received. The accounting records included the following information:
 - a. Identify contract awards
 - b. Record obligations and unobligated balances
 - c. List assets purchased with the funds
 - d. Record liabilities
 - e. Record expenditures and income
- c) MPTN's Department of Finance shall maintain effective control and accountability for all self-determination contract funds received and for all Federal real property, personal property, and other assets furnished for use by MPTN under the self-determination contract.
- d) MPTN's Department of Finance shall permit the comparison of actual expenditures with amounts budgeted by the tribe for each self-determination contract.
- e) MPTN's Grant Operating Departments, Department of Finance, and the Office of the Chief of Staff shall determine reasonableness, allowability, and allocability of self-determination contract costs based upon the terms of the self-determination contract and the tribe's applicable OMB cost principles
- f) MPTN's Department of Finance shall contain accounting records that are supported by documentation and other primary records that support self-determination contract fund expenditures
 - a. Canceled checks, paid bills, payroll records, time and attendance records, contract award documents, purchase orders

B. Standards for Procurement Management System

MPTN Standards to meet the required Procurement Management System Standards are as follows:

- a) MPTN's Procurement Department shall ensure that its vendors and/or subcontractors perform in accordance with the terms, conditions, and specifications of their contracts or purchase orders.
- b) MPTN's Procurement Department maintains written standards of conduct governing the performance of its employees who award and administer contract. See attached REGS.49
- c) MPTN's Procurement Department shall conduct all major procurement transactions by providing full and open competition, to the extent necessary to assure efficient expenditure of contract funds.
 - a. Indian Preference and Tribal Preference shall be applied in any procurement award.
- d) MPTN's Procurement Department will compare leasing and purchasing alternatives to determine which is more economical.

- e) MPTN's Procurement Department shall make procurement awards only to responsible entities that have the ability to perform successfully under the terms and conditions of the proposed procurement.
- f) MPTN's Procurement Department shall maintain records on the significant history of all major procurement transactions.
- g) MPTN's Procurement Department will be responsible for processing and settling all contractual and administrative issues arising out of procurement.
 - a. Settlement of any protests, disputes or claims
- h) Each subcontract entered into under the Indian Self-Determination and Education Assistance Act shall at a minimum:
 - a. Be in Writing
 - b. Identify the interested parties, their authorities, and the purposes of the contract
 - c. State the work to be performed under the contract
 - d. State the process for making any claim, the payments to be made, and the terms of the contract, which shall be fixed; and be subject to sections 7(b) and (c) of the Indian Self Determination and Education Assistance Act.

C. Standards for Property Management System

MPTN's Property Management system shall account for all property furnished or transferred by the Secretary for use under a self-determination contract or acquired with contract funds. (CFR 900.51)

The Property Management System tracks:

- a) personal property with an acquisition value in excess of \$5,000 per item
- b) sensitive personal property such as firearms which are subject to theft or pilferage and are managed by the custodian of such assets.
- c) Real property provided by the Secretary for use under the contract.
- d) MPTN Annual Equipment Inventory is available upon request.

MPTN's property management system maintains the following records:

- a) accurately describes the property
 - a. serial number, if applicable
 - b. other identification number
- b) source and acquisition date
- c) cost and federal share
- d) location, use and condition of property
- e) date of disposal and sale price if any.
 - a. An Asset Disposal Form is used to track inventory when the item is no longer operational or unneeded.
- MPTN through our Federal Audit Clearing House use a federal Data Collection Form (DCF) for collection and storage of our annual audit information for every funding source the Tribe receives. Each DCF provides a summary of the annual audit including a list of our annual grant expenditures and audit findings, if any. Any funds relating to an approved EMA award would be handled using this same system. MPTN shall make available to Wilmington Trust, the Trustee, a copy of the federal grant Data Collection Form prepared and submitted to the Federal Audit clearing house in compliance with the federal Single Audit Act including audit findings related to these grant funds, if any, but excluding MPTN's audit report.

- MPTN will maintain and make publicly available all documentation submitted in support of the funding request, as well as records supporting all expenditures of EMA funds, subject to approved MPTN Tribal policies, procedures and law. No confidential or personally identifiable information will be posted in any public notification from the Tribe pursuant to Tribal and Federal policies. All tribal laws regarding publicly available documentation requirements and policies will be followed.
- Any questions regarding documents posted for public participation will be directed to the Lead Agency, MPTN Public Works Department to the MPTN Public Works Director. The public will can submit any questions directly to the Public Works Director via email or will be able to call the Public Works Department to talk to the Public Works Director directly. Public Works will endeavor to answer public inquiries immediately but no later than (10) days from the date of the request. If copies of documents are requested Public Works will provide the individuals' copies of all requested documents in the earliest manner possible.
- MPTN owns all of the cited diesel vehicles and will own any replacement vehicles. Support of these activities will be undertaken by appropriate MPTN employees as a part of their regular job duties.
- MPTN's Public Works Department (Lead Agency) will be responsible to select a scrapping vendor to "scrap" the cited diesel vehicles outlined in the MPTN's Appendix D-4. Information on vendor selection, date of scrapping, and all documentation detailing the specifics of this part of the project will be included in reports.
- Upon the termination or completion of any EMA, any unused EMA funds shall be returned by MPTN to the Trustee, to ultimately be returned to the Tribal Allocation Subaccount.

Detailed Description of Mitigation Action Item Including Community and Air Quality Benefits (5.2.2):

Mashantucket Pequot Tribal Nation (MPTN) is a beneficiary of the Trust Settlement and participated in the first funding cycle. In this, second funding cycle, our request for use of funds will to replace (2) eligible diesel vehicles. The vin numbers, make and model numbers, year, and ownership were sent to ITEP for review; the result of which was a response that both were eligible. The (2) trucks being replaced are: 1) a 1996 -Class 4- Chevy GMT-400 Box Truck [vin#: 1GBKC34F1TJ104662] and 2) a 2006 - Class 6- Navistar - International MA025 DuraStar 4300 Plow Truck [vin#: 1HTMMAAM16H268629].

Funding is being requested to purchase (2) replacement diesel vehicles directly relative to the vehicles they are replacing. 1) a model year 2019 -Class 4- Ford F-450 4x2 XL 6.7 Diesel Box Truck and 2) a model year 2020 -Class 6- Navistar International MV607 SBA]. Please refer to (Attachment D – Detailed Cost Estimates)

These vehicles are to be housed and used within Mashantucket, Connecticut (reservation) at the Tribe's Public Works Department. Both will be used all year round; however, the box truck will be primarily used for road striping and will be more dependent on weather conditions; whereas the dump plow truck will be used in all seasons regardless of weather. Both trucks will be used by Public Works staff around the entirety of the Mashantucket Reservation including projects on or near Foxwoods Resort Casino.

Mashantucket is disadvantaged by being located within ozone Non-Attainment Area, of which NOx is a precursor pollutant. There are no major source emitters of NOx, or any source that contributes to an exceedance of the Ozone NAAQs, located within Mashantucket. Thus the non-attainment designation is solely related to up wind sources.

Estimate of Anticipated NOx Reductions (5.2.3):

Replacement of the 1996 Chevy Box Truck (class 4), according to the (DEQ) software shows a reduction of <u>95.4%</u> NOx when replaced with a same class 2019 equivalent (Ford F-450). Please refer to attached DEQ data. Replacement of the 2006 International Plow Truck (class 6), according to the (DEQ) software shows a reduction of <u>89.6%</u> NOx when replaced with a same class 2020 equivalent (Navistar International MV607 SBA). Please refer to (*Attachment I – MPTN DEQ YR2 Report*).

5) Quarterly reports as required by the Trustee or the Court in accordance with Tribal policy No confidential or personally identifiable information will be posted in any public notification from the Tribe pursuant to Tribal and Federal policies. All tribal laws regarding publicly available documentation requirements and policies will be followed.

As outlined above, the D-3, D-4, reports, and all documentation pertaining to the EMA projects will be available to the public. Contact information for the Public Works Director, Keith Gove, from the Public Works Department (Lead Agency) will be posted on the website listing for any community members who have questions or request documentation pertaining to the EMA project of information pertaining to the Mitigation Settlement.

MPTN will maintain and make publicly available all documentation submitted in support of the funding request, as well as records supporting all expenditures of EMA funds, subject to approved MPTN Tribal policies, procedures and law. No confidential or personally identifiable information will be posted in any public notification from the Tribe pursuant to Tribal and Federal policies. All tribal laws regarding publicly available documentation requirements and policies will be followed.

Any questions regarding documents posted for public participation will be directed to the Lead Agency, MPTN Public Works Department to the MPTN Public Works Director. The public will be allowed to submit questions directly to the Public Works Director via email or will be able to call the Public Works Department to talk to the Public Works Director directly. Public Works will endeavor to answer public inquiries immediately but no later than 7 days. If copies of documents are requested Public Works will provide the individuals' copies of all requested documents in the earliest manner possible.

<u>Note on compliance of "scrapping" and reporting:</u> Eligible Local Freight Trucks (Medium Trucks). MPTN replacement vehicles will be scrapped as described on page 64 of 68 of the Dkt 51-2 Tribe Beneficiary Trust Agreement which reads, *"Scrapped" shall mean to render inoperable and available for recycle, and, at a minimum, to specifically cut a 3-inch hole in the engine block for all engines. If any Eligible Vehicle will be replaced as part of an Eligible project, Scrapped shall also include the disabling of the chassis by*

cutting the vehicle's frame rails completely in half." MPTN will comply with this requirement and provide proof of scrapped vehicles for reporting and compliance. D-2 Option 6: Class 4-7 Local Freight Trucks (Medium Trucks).

Describe any cost share requirement to be placed on each NOx source proposed to be mitigated (5.2.8):

Mashantucket Pequot Tribal Nation is proposing 15% cost share of the total project costs as part of this application. These funds will be appropriated by Tribal Council to the MPTN Public Works Department (Lead Agency) to support the full cost of this mitigation project [the replacement of 2 eligible diesel trucks]. The amount of cost share is indicated in the section labeled "PROJECT BUDGET" in Appendix B on pdf-page 9 of 52 of this document.

Describe how the Beneficiary complied with subparagraph 4.2.8, related to notice to U.S. Government Agencies (5.2.9):

Per page 23 of the document labeled "Dkt 51-2 Tribe Beneficiary Trust Agreement", as outlined in Section 4.2.8 "Notice of Availability of Mitigation Action Funds", Mashantucket Pequot Tribal Nation – upon request from a Federal Agency representative -- will not later than 30 Days after being deemed a Beneficiary, send via certified mail (and email) copies of its official Appendix D-3 and official Appendix D-4 to the following Federal agencies: 1) The Department of the Interior's National Park Service, Air Resources Division, 2) Tim Allen or other designated representative, U.S Fish and Wildlife Service, National Wildlife Refuge System Branch of Air Quality, 3) The Department of Agriculture: Linda Geiser or other designated representative, National Air Program Manager and 4) The Department of Agriculture: Bret Anderson or other designated representative National Air Modeling Coordinator.

If applicable, describe how the mitigation action will mitigate the impacts of NOx emissions on communities that have historically borne a disproportionate share of the adverse impacts of such emissions (5.2.10):

Replacement of the 1996 Chevy Box Truck (class 4), according to the (DEQ) software shows a reduction of <u>95.4%</u> NOx when replaced with a same class 2019 equivalent (Ford F-450). Please refer to attached DEQ data. Replacement of the 2006 International Plow Truck (class 6), according to the (DEQ) software shows a reduction of <u>89.6%</u> NOx when replaced with a same class 2020 equivalent (Navistar International MV607 SBA). Please refer to (*Attachment I – MPTN DEQ YR2 Report*).

The Tribe, by nature of being an Indian Tribe and minority population, is also a socially-disadvantaged population. Tribes have struggled with inter-generational trauma resulting from the first European settlers to the Country, the creation of the U.S. Federal Government and legislation created by State of Connecticut outlawing the word "Pequot" from being spoken, the selling off of tribal land, and the dispersion of our people throughout the country. During the years of persecution, the traditional ways of life involved with being one with the Earth and harmony with nature were dismissed and ultimately the Tribes could only choose to adapt or they were otherwise forcefully dispersed off their lands. As Tribes continued to shrink and suffer from westernization and subsequently the industrial revolution; our way of life has been disparaged. Only recently where the Tribe was given Federal recognition with rights to some of our land back.

MPTN owns Foxwoods Resort and Casino. Having a casino adds to the NOx emissions that affect our community simple by its nature. Passenger vehicles, trucks of all sizes, bus transportation, forklift and other distribution/warehouse machinery, and others significantly increase poor air quality in Mashantucket and the surrounding towns because the casino is a centralized transportation hub with a minor footprint considering the traffic that it has 7 days a week, 365 days a year. The casino, its hotels, and many of the services provided never close. The proposed 2019 and 2020 replacements will greatly reduce harmful NOx emissions during operation and idle times. MPTN has attached a GIS Map of our Reservation in which both vehicles will be used and stored. Please refer to (Attachment H - MPTN Reservation GIS Map).
