# **Detailed Description Of Mitigation Action Item Including Community And Air Quality Benefits (5.2.2)**

The Confederated Tribes and Bands of the Yakama Nation ("Yakama Nation") is pleased to submit the Yakama Nation's Round 3 Diesel Vehicle Replacement Project ("Project") under the Environmental Mitigation Trust Agreement for Indian Tribe Beneficiaries dated November 30, 2018 ("Indian Tribe Trust Agreement"). The Project is primarily submitted under Sections 1(f)(1) and 2(e)(1) of Appendix D-2 to the Indian Tribe Trust Agreement. The Project also includes a light duty zero emission vehicle ("ZEV") component under Section 9(c)(1) of Appendix D-2.

The Yakama Nation's Project would deploy one all new diesel bus servicing the Yakama Nation's tribal school. The new school bus will be a new Thomas front engine diesel school buses, Model Profile: Thomas Built Buses Saf-T-Liner C2 341TS. The eligible vehicle it is replacing is a 2005 Thomas school bus, License Plate I-02622, VIN 4UZAAXCS65CU30950. This bus is an "Eligible Bus" under Section 2 of Appendix D-2 to the Indian Tribe Trust Agreement because it is a diesel bus that is older than 2009 with a Gross Vehicle Weight Rating greater than 14,001 lbs. A replaced bus will be rendered inoperable (meaning, at a minimum, it will have a 3-inch hole cut in the engine block and its frame rails will be cut completely in half) and the remaining usable parts will be recycled or scrapped.

The Yakama Nation's Project would also deploy one all new diesel truck servicing the Yakama Nation's roads department. The eligible vehicle it is replacing is a model year 2000 Kenworth T800 B/Truck Tractor, VIN 1XKDPBEX1YR867191. This vehicle is an eligible vehicle under Section 2 of Appendix D-2 to the Indian Tribe Trust Agreement because it is a diesel vehicle that is between 1992 and 2009 with a Gross Vehicle Weight Rating greater than 14,001 lbs. A replaced vehicle will be rendered inoperable (meaning, at a minimum, it will have a 3-inch hole cut in the engine block and its frame rails will be cut completely in half) and the remaining usable parts will be recycled or scrapped.

For all replaced vehicles, the old engine and chassis will be permanently disabled. Disabling the engine consists of cutting or punching a three-inch hole in the engine block. Disabling the chassis entails cutting completely through the frame/frame rails on each side of the vehicle/equipment at a point located between the front and rear axles. If other, pre-approved scrapping methods were used, details and documentation will be included, including photos of the disabled engine/chassis and/or a signed Certificate of Vehicle/Engine Destruction.

The Yakama Nation's Project also includes a light duty ZEV component. Section 9 of Appendix D-2 permits beneficiaries to use up to 15% of their funds "on the costs necessary for, and directly connected to, the acquisition, installation, operation and maintenance of new light duty zero emission vehicle supply equipment for projects specified below." The Yakama Nation intends to use up to that full amount to install a light duty ZEV charging station, with the final number of chargers dictated by the approved budget and actual installation costs. For its first round project under the Indian Tribe Trust Agreement, the Yakama Nation is planning to install

two Level 2 chargers, the ChargePoint CT4025-GW1 Gateway Unit and the ChargePoint CT4025 unit. For the Project, if funds are available, the Yakama Nation is planning to add another two chargers (another ChargePoint CT4025 unit) to that charging station.

The Yakama Nation contracted with the Askman Law Firm for consultation services on the Project. The Askman Law Firm has already provided support for the Project by assisting with designing the Project and with preparing this application. The Askman Law Firm will also provide support in implementing the Project and with submitting the required reports. Attached hereto is a fee request from the Askman Law Firm with additional detail on their consultation services.

The Yakama Nation believes the Project will result in several significant air quality and community benefits, including but not limited to substantially reduced tailpipe emissions (including NOx), reduced greenhouse gas emissions, better vehicle performance and propulsion system durability, and increased comfort for the operator and passengers.

## **Estimate Of Anticipated NOx Reductions (5.2.3)**

The Yakama Nation does not have exact information on the NOx emissions from the vehicle it is replacing. Accordingly, the Yakama Nation used the Diesel Emissions Quantifier (DEQ) tool provided by the United States Environmental Protection Agency to calculate the anticipated NOx reduction. This is the fourth school bus that the Yakama Nation is replacing, and it will average about 26,000 miles per year and about 118 hours of idling per year. In order to calculate the diesel fuel input, the Yakama Nation multiplied the DEQ tool's default annual fuel (1,360 gallons) times the Yakama Nation's average mileage (26,000 miles) divided by the DEQ tool's default annual mileage (14,084 miles) to come up with 2,510 gallons. The Yakama Nation used these numbers to run a calculation on annual NOx for the bus with a 2005 model year, which resulted in 0.174 annual tons of NOx, and to run a calculation on annual NOx for the buses with a 2020 model year, which resulted in 0.018 annual tons of NOx. The result is an annual NOx reduction of 0.156 tons per year, or 312 pounds per year, for the bus. This equates to a 90% reduction.

The Yakama Nation also used the DEQ for the truck, which will average about 10,000 miles per year and about 120 hours of idling per year. In order to calculate the diesel fuel input, the Yakama Nation multiplied the DEQ tool's default annual fuel (1,463 gallons) times the Yakama Nation's average mileage (10,000 miles) divided by the DEQ tool's default annual mileage (14,962 miles) to come up with 978 gallons. The Yakama Nation used these numbers to run a calculation on annual NOx for the truck with a 2000 model year, which resulted in 0.133 annual tons of NOx, and to run a calculation on annual NOx for the truck with a 2020 model year, which resulted in 0.008 annual tons of NOx. The result is an annual NOx reduction of 0.125 tons per year, or 250 pounds per year, for the bus. This equates to a 94% reduction.

As such, for the Yakama Nation's Project involving the replacement of one school bus and one truck, the Yakama Nation anticipates an annual NOx reduction of 562 pounds per year, a reduction of 92%.

## **Describe How The Beneficiary Will Make Documentation Publicly Available (5.2.7.2)**

The Yakama Nation will maintain and make publicly available all documentation submitted in support of its funding request and all records supporting all expenditures of any funds it receives, subject to applicable laws applicable laws governing the publication of confidential business information and personally identifiable information. In response to any inquiry from the public to request additional information and documents related to the funding request and expenditure of funds, such documentation shall be made publicly available by appointment for review at tribal headquarters. In addition, under Section 5.3 of the Indian Tribe Trust Agreement the Trustee will post on its public-facing website the semiannual reports submitted to the Trustee by the Yakama Nation.

The Yakama Nation's certification of Section 7 of its Certification for Beneficiary Status Under Environmental Mitigation Trust Agreement is subject to the Yakama Nation's governing policies on the release of its records, which establishes the Yakama Nation's position on the procedures for making records publicly available and on the handling of requests by outside parties for the release of various categories of tribal records and the procedures for handling such requests. The Yakama Nation protects from disclosure privileged and protected information. The Yakama Nation will endeavor to respond to requests for records within three weeks.

# Eligible Mitigation Action Management Plan Including Detailed Budget And Implementation And Expenditures Timeline (5.2.4)

#### PROJECT SCHEDULE AND MILESTONES

The Yakama Nation estimates the Yakama Nation's Project will follow the below estimated schedule. During the course of the Project the Yakama Nation will provide semiannual status reports. The Project can be broken into the following steps.

## Step 1. Trustee Award (3 months) [November 2020]

The Yakama Nation's Project will not begin until the Trustee has distributed funds to the Yakama Nation. The Yakama Nation assumes this will occur by November 2020. The contractual application fee will be expended when the funds are distributed.

## Step 2. Vehicle Procurement and delivery (18 months) [May 2022]

This step will include purchasing the new vehicles (bus and truck) and rendering the old vehicles inoperable. The Yakama Nation anticipates a vehicle delivery time of about 9-12 months after a vehicle is ordered. The funds for each vehicle will be expended when the vehicle is ordered, and the vehicle accessories will be purchased when the vehicle is delivered. Any delivered vehicles will be registered and insured by the Yakama Nation. Once a new vehicle is delivered, the vehicle being replaced will be rendered inoperable with that process documented by photos and/or a signed certificate of destruction, with those funds expended at that time.

## Step 3. Light Duty ZEV Installation (18 months) [May 2022]

The Yakama Nation anticipates that steps 2 and 3 can mostly be performed simultaneously. This step involves finalizing plans for the charging station and seeking the necessary permits from local authorities to install the systems. During this step, the Yakama Nation will be working with Yakama Power to develop a site and installation plan for the charging stations, including any site engineering (such as civil, electrical, and mechanical), construction, and equipment installation. The costs for the charging infrastructure equipment will be expended when the parts are ordered once the site design is complete. The costs for the charging infrastructure installation will be expended as infrastructure is completed.

## Step 4. Project Completion (1 month) [June 2022]

Once the replaced vehicle is rendered inoperable, the Yakama Nation will issue a final report summarizing implementation and will close out the project with the Trustee. Assuming that the award occurs in November 2020, the Yakama Nation estimates project completion will occur in May 2022.

## **Detailed Plan For Reporting On Eligible Mitigation Action Implementation (5.2.11)**

No later than six months after the Yakama Nation receives its first disbursement of Trust Assets, and thereafter no later than January 30 (for the preceding six-month period of July 1 to December 31) and July 30 (for the preceding six-month period of January 1 to June 30) of each year, the Yakama Nation shall submit to the Trustee a semiannual report describing the progress implementing the Yakama Nation's Project during the six-month period leading up to the reporting date (including a summary of all costs expended on the Eligible Mitigation Action through the reporting date). The first semiannual report will be submitted by May 12, 2021.

The Yakama Nation's reports shall include a complete description of the status (including actual or projected termination date), development, implementation, and any modification of the Yakama Nation's Project. The Yakama Nation does not anticipate that these reports will be onerous because the Project primarily consists of obtaining two new buses. If necessary, the Yakama Nation will engage the services of external vendors to review and/or audit these reports. These reports shall be signed by an official with the authority to submit the report for the Yakama Nation and will contain an attestation that the information is true and correct and that the submission is made under penalty of perjury.

The Askman Law Firm, L.L.C. is pleased to have had the opportunity to assist the Yakama Nation with their application for the third round of VW trust funds. This letter serves as the Firm's fee request to be submitted as part of the Yakama Nation's application. The Firm is requesting a fee to be funded as an eligible administrative expense with trust funds the Yakama Nation receives. The Firm is requesting a fee for the Firm's services already provided; along with an estimated fee based on the services the Firm anticipates providing following approval of the application. These fees will be in addition to any trust funds received by the Yakama Nation.

As you are aware, the Firm informed the Yakama Nation of their eligibility to become a beneficiary under the Trust Agreement. The Firm also advised the Yakama Nation on how they could benefit from becoming a beneficiary, including providing the Yakama Nation with an analysis of the amount of funds the Yakama Nation should receive from the trust and preparation of an application strategy to maximize that value for the Yakama Nation. When the Yakama Nation decided to apply to become a beneficiary and apply for trust funds, the Firm assisted the Yakama Nation in preparing its applications for all rounds.

The Firm is submitting its fee request to be paid from trust funds awarded to the Yakama Nation as an eligible administrative expense under the Trust Agreement. Appendix D-2 to the Trust Agreement includes a section for "Eligible Mitigation Action Administrative Expenditures." That section permits the Yakama Nation, as a Beneficiary, to "use Trust Funds for actual administrative expenditures (described below) associated with implementing such Eligible Mitigation Action, but not to exceed 15% of the total cost of such Eligible Mitigation Action." That section goes on to describe eligible administrative expenditures to include, *inter alia*, "[c]ontractual including all contracted services," "[c]ontracts for evaluation and consulting services," and "[o]ther costs including … professional services." It also specifies certain items that do not quality as eligible administrative expenditures, including fees prior to October 2, 2017 and any expenses in preparing an

Appendix D-3. The services that the Firm provided to the Yakama Nation in preparing its application, as well as the services that the Firm will provide to the Yakama Nation in implementing its project, qualify under those provisions and the guidance provided by the Trustee and the U.S. Department of Justice.

As of the time of this Fee Request, the Firm is requesting a fee of \$3,080.00 for 8.8 hours spent assisting the Yakama Nation with their application for VW third round trust funds. Additional detail is provided in the attached invoice, including a description of the person who worked on the matter, the date of the work, the time spent on the task, the task performed, and the hourly rate.

The Firm estimates that any future assistance provided to the Yakama Nation in implementing the project will cost take about 26 hours at \$350 per hour. We estimate the hours based on performing the following tasks: 3 hours for contracting and purchase of the new vehicles; 3 hour for arranging for rendering the old vehicles inoperable; 15 hours for preparation of status reports on the project; and 5 hours for closing out the project including preparation of a final report. Finally, the fee has been adjusted to eliminate a cost share by the estimated administrative costs so that the budget equals the allocation, resulting in a total estimate of \$11,991.00.
