

ADDENDUM TO D-4 BENEFICIARY ELIGIBLE MITIGATION ACTION CERTIFICATION

5.2.2

During the third funding cycle of the Volkswagen (VW) Settlement Environmental Mitigation Trust for Indian Tribes, the Colorado River Indian Tribes will replace two government-owned vehicles:

- One (1) Government-Owned 2007 Blue Bird School Bus, *Eligible per Class 4-8 Buses*
- One (1) Government-Owned 1994 Chevrolet Dump Truck, *Eligible per Class 4-7 Med. Freight Truck*

The Tribe will also establish Light Duty Zero Emission Vehicle Supply Equipment via:

- Two (2) Dual-Port Level 2 Electric Vehicle (EV) Charging Stations at the Blue Water Resort & Casino located in the City of Parker, AZ on the Colorado River Indian Tribes Reservation.

The eligible vehicles selected to be replaced are the following:

The eligible vehicles will be scrapped and replaced with a new low-emission diesel school bus as well as a new low-emission diesel dump truck. The Colorado River Indian Tribes understands the term "scrapped" means to render inoperable and available for recycle, and, at minimum, to specifically cut a 3" or larger hole in the engine block of each vehicle and, for vehicles to be replaced as part of this project, to disable the chassis by cutting the vehicles' frame rails completely in half.

The total cost of the replacement vehicles will be \$201,186.50. Costs have been obtained from qualified dealers and reflect delivery to Parker, Arizona, on the Colorado River Indian Tribes Reservation.

The total cost of the light duty zero emission electric vehicle charging stations will be \$29,000. The charging stations will be located at the Blue Water Resort & Casino, adjacent to Highway 95 in Parker, Arizona. The casino property is well-lit, has sufficient electrical capacity for the charging stations, and maintains 24/7 desk service and 24/7 security inside and throughout the facility.

The electric vehicle charging stations are a part of a corridor project to "Electrify the West" with zero emission charging stations available to the public to power their electric vehicles. Very few electric vehicle charging stations exist within the local area.

The community and air quality benefits from the mitigation project will include energy efficiency and a reduction in pollution, including reduced emissions of NOx, reduced fuel consumption, and reduced fuel costs.

5.2.3

The Eligible Mitigation Actions to be undertaken by the Colorado River Indian Tribes will result in a significant reduction in NOx emissions and other pollutants, fuel consumption, and fuel costs. Data regarding diesel emissions reduction has been calculated using the U.S. Environmental Protection Agency Diesel Emissions Quantifier (DEQ) and the Eligible Mitigation Actions taken for vehicle replacement are as follows:

5.2.7.2

The Colorado River Indian Tribes is committed to maintaining and making publicly available all documentation submitted in support of the Funding Request and all records supporting all expenditures of Eligible Mitigation Action funds, subject to applicable laws governing the publication of confidential business information and personally identifiable information.

As stated in D-3, the Colorado River Indian Tribes will establish a webpage dedicated to the funding received from the VW Settlement Environmental Mitigation Trust for Indian Tribes, which will include a link for members of the public to request additional information and documents related to the funding request and expenditures of funds. The Colorado River Indian Tribes will endeavor to respond to such requests within ten (10) business days and, when documents are requested, will advise the individual within that timeframe of the procedure for reviewing such documents.

5.2.8

This project requires no cost-share. The total cost of the project is \$231,474, and it has been determined that the Colorado River Indian Tribes is eligible for \$231,474 from the Environmental Mitigation Trust in the third funding cycle.

Our proposal includes the following:

1. Two (2) CT4021-GW1, Dual Output Gateway Option, Pedestal Mount Station - 208/240V @30A with Cord Management and 18' Cord. (see attached).
2. Scope of Work –
 - a. From electric room and existing panel, run pipe, conduit 75 feet to outside door.
 - b. Run 16 feet across cement sidewalk to middle of two parking spaces and cement pad.
 - c. Run conduit to 2nd charging station location.
3. Electric materials including circuit breakers, conduit and conductors from POC to charging station.
4. Form/Pour two concrete pads for ChargePoint pedestal charging stations.
5. Installation, Commissioning and Programming of 2 Dual pedestal charging stations.
6. A & E services including site visit, construction drawings, electrical engineering and permit processing for project approval from Tribe.

Since we haven't seen the inside of the electric panel and have not done a Load Study, we are assuming there is at least 4, 40 amp breakers to use for the two charging stations. If there is not enough power upon our site review, the cost of upgrading the breakers will be the responsibility of Blue Water Resort & Casino
