# Description of Status (include actual or projected termination date):

The new dump truck was shipped in August 2020 and was delivered to Golovin, Alaska for winter storage; the barge was unable to travel further due to weather that often affects the end of the barge season. It is scheduled, however, to arrive in White Mountain from Golovin via barge by July 31, 2021. Upon satisfactory delivery and inspection of the new vehicle, the Tribe will document the decommission of the old vehicle and submit the final report to the trustee in January 2022.

**Projected Termination Date: August 31, 2021** 

## Development (planning work accomplished for the project):

Expected barge delivery of the new dump truck from Golovin to White Mountain: July 31, 2021

Once the new dump truck arrives and has been satisfactorily inspected by the Tribe, the old dump truck will be scrapped as indicated in the Tribal Trust agreement and the destruction will be documented.

The final report will be submitted to the trustee in January 2022.
