# Description of Status (include actual or projected termination date):

The contract to install the first electric vehicle charging station at the Florence casino has been signed. The contractor has been on site and met with the casino maintenance staff. The location for the charger has been identified and marked. The casino staff will work with the contractor to pour a concrete base for the charger, and it will be installed on the concrete base. We expect the project to be completed this summer.

The Coos Bay casino charging station will be installed after the work is done in Florence.

# Development (planning work accomplished for the project):

The project is ongoing. Casino maintenance staff has the instructions for installation and the location where the charger will be located. Further development will be between casino staff and the contractor (Reese Electric).

#### Implementation (purchases, construction/installation of infrastructure, etc.):

No purchases have been made so far by CTCLUSI. The contractor (Reese Electric) has already purchased the charging station but we have not paid them yet.

Any modification to each approved Eligible Mitigation Action (including changes to equipment costs, tribal cost share, etc.):

So far, no changes. We are contemplating expanding the Coos Bay charging station with level three chargers, if we can get funding through the fourth funding cycle of the VW Settlement. However, at this time we have not deviated from the plan as laid out in the D-4.
