VW Settlement Beneficiary Mitigation Plan for the State of Washington Semi-annual report

Background:

In 2015, the U.S. Environmental Protection Agency (EPA) issued a notice of violation to the automaker Volkswagen (VW) after it was discovered that the company illegally installed software on many of its diesel vehicles. The software allowed the vehicles to pass emissions tests when, in reality, they were emitting between 10 and 40 times the permitted levels of harmful nitrogen oxides.

These actions violated the federal Clean Air Act, violations that VW resolved in a series of settlements in 2016 and 2017. The settlements require VW to fund Environmental Mitigation Trust Agreements for State and Indian Tribe Beneficiaries. On March 15, 2017, the U.S. District Court for the Northern District of California ("the Court") appointed Wilmington Trust, N.A. as the Trustee (the "Trustee").

On November 3, 2017, Washington's Governor Jay Inslee identified the Washington State Department of Ecology (Ecology) as the Lead Agency for purposes of Washington's participation in the Environmental Mitigation Trust Agreement for State Beneficiaries (the "State Trust"). On January 29, 2018 the Trustee filed notice with the Court that Washington satisfied its filing requirements, in accordance with the State Trust agreement, identifying Washington as a State Trust beneficiary.

In accordance with the Trust agreement, the Trustee allocated Washington \$112.7M in federal settlement funds. The State Trust's purpose is to fund environmental mitigation projects that reduce emissions of nitrogen oxides ("NOx") where the subject vehicles were, are, or will be operated. On November 6, 2019 Washington Filed its Beneficiary Mitigation Plan with the Trustee, which lays out spending priorities and high-level principles that will be used to guide the selection of eligible mitigation projects to meet the purpose of the State Trust.

Ecology submitted Washington's first Eligible Mitigation Action (EMA) request that the Trustee approved on July 19, 2019. On September 17, 2019, Ecology received its first disbursement of trust assets. In accordance with the State Trust agreement, Ecology's first semi-annual report is due no later than six months after receiving its first disbursement of Trust Assets.

Subsequent semi-annual reports are due no later than January 30 (for the preceding six-month period of July 1 to December 31) and July 30 (for the preceding six-month period of January 1 to June 30) of each year. Ecology will report on additional projects underway with budgeted VW funds in subsequent semi-annual reports.

Expected Termination Date	6/30/2023
Project Status	Ecology has grant agreements in place with six transit authorities in Washington for about \$13,000,000 to purchase 47 all-electric transit buses. The Washington Department of Enterprise Services has replaced the expired transit bus contract with a new contract. Transit awardees have received one electric bus and placed orders for another six electric buses. Ecology expects the remaining transit awardees to order their transit buses by 12/30/21.
Summary of Costs Expended	Ecology accrued administrative costs of approximately \$81,866.18 and \$300,000.00 in project costs during this (January - June 2021) reporting period. Ecology anticipates requesting reimbursement for costs expended in this reporting period in September 2021.
Summary of Expenditures in the Next Reporting Period	All expenditures will be on a reimbursement basis. Ecology anticipates accruing administrative costs of approximately \$106,307.47 and project costs of zero in the next (July – December 2021) reporting period. Project Status	Ecology has a signed grant agreement in place with Washington State Ferries (WSF) for \$35,000,000 for the conversion of a diesel ferry to a hybrid electric ferry. Siemens delivered their proposal for the development of Construction Plans, Specifications and Estimates (PS&E). WSF revised the project schedule to accommodate completion of the PS&E. The project construction scheduled start date has changed to May 18, 2022. WSF is modifying the phasing timelines of the project and work scope completed for each milestone of the project prior to the construction phase to better align with project goals and the contractor completing several items in parallel. WSF and Siemens have executed procurement of materials with a long lead-time delivery. Long lead materials have been purchased on schedule to be delivered September 2021. WSF Project Engineers have begun the Construction Planning phase of the project to align with the changed construction start date of May 18, 2022.
