Due to the COVID-19 crisis, most of the awardees were impacted in various ways. Timelines were affected significantly, and projects have moved slower than anticipated. All projects selected for actions 1,2,6,7, and 8, are electrification projects which replace diesel equipment with electric and will operate in overburdened communities.

### **Mitigation Action 1**

#### **Regional Industries – Electric Garbage Trucks- FUNDS WERE RETURNED TO THE VW TRUSTEE**

DEP awarded \$1,717,000 to Regional Industries to purchase 5 battery electric garbage trucks to be operated in Elizabeth, NJ. Regional is reviewing infrastructure plans and vehicle offerings by different manufacturers. The vehicle offerings were not conducive to Regional's operation and therefore this project was terminated and funds were returned to the Trustee.

#### **International Motor Freight/IKEA**

DEP awarded \$262,500 to International Motor Freight/IKEA to purchase 1 all electric drayage truck to be operated and domiciled at Port Newark, NJ. IMF has finalized all grant paperwork and expects to take delivery of the truck in 2022.

#### **Hudson County Motors- FUNDS WERE RETURNED TO THE VW TRUSTEE**

DEP awarded \$1,167,000 to Hudson County Motors to purchase 4 all electric drayage trucks to operate in Hudson and Essex Counties. Hudson County Motors is finalizing agreements with truck partners. Hudson County Motors was unable to secure partners which had old trucks within the specifications of the Consent Decree, therefore this project was terminated, and the funds were returned to the Trustee.

#### **eTrucks**

DEP awarded a total of \$8,264,851 to Railroad Construction Company, Inc., International Motor Freight, The City of Perth Amboy, and The City of Paterson. A total of 21 trucks will be replaced with all electric trucks and charging stations. All projects are in overburdened communities in New Jersey.

## **Mitigation Action 2**

### NJ Transit Electric Buses – Camden

DEP awarded \$8 million to NJ Transit to purchase 8 electric transit buses to be operated in Camden, NJ. NJ Transit's bid solicitation for buses was pushed back to the fall of 2021 therefore a vendor will be selected towards the end of 2021, beginning of 2022.

### Student Transportation of America

DEP awarded \$1,975,000 to Student Transportation of America to purchase 5 electric school buses and charging stations which will be operated in Trenton, NJ. The school buses have been delivered and the infrastructure is being finalized.

### eBuses

DEP awarded a total of \$7,679,610 to A-1 Limousine, Inc., Durham School Services LP, Highland Electric Transportation, and New Jersey City University. These four projects will replace 16 diesel buses with all electric buses along with the necessary infrastructure. All buses will operate in overburdened communities.

## **Mitigation Action 6**

### City of Jersey City

DEP awarded \$2,046,000 to the City of Jersey City to purchase 5 electric garbage trucks and charging stations which will operate throughout Jersey City, NJ. The garbage trucks have been delivered and the infrastructure is being completed.

### IKEA – FUNDS WERE RETURNED TO THE VW TRUSTEE

DEP awarded IKEA Distribution Services of North America \$825,000 to purchase 5 electric box trucks and charging stations which will operate in Cherry Hill, Camden, Jersey City and Hoboken. IKEA is awaiting price quotes from various manufacturers. IKEA was unable to move this project forward therefore the project was terminated, and funds were returned to the Trustee.

## Mitigation Action 7

### United Airlines

DEP awarded United Airlines \$2,566,529 to purchase 39 piece of electric ground support equipment. DEP also awarded the Port Authority of NY/NJ \$1,000,000 for the electric charging infrastructure to be installed at Newark Liberty International Airport. United paused this project due to the impact of the COVID-19 pandemic. Fortunately, United has decided to move forward with this project and a grant agreement is being finalized.

### eGSE

DEP awarded a total of \$4,674,774 to Delta Airlines, Signature Flight, and JetBlue Airlines. A total of 57 pieces of airport ground support equipment will be replaced with all electric equipment and charging infrastructure will also be installed. All eGSE will operated in overburdened communities.

## Mitigation Action 8

### Red Hook Terminals

DEP awarded \$2,467,000 to Red Hook Terminals to purchase 10 electric yard tractors and charging stations in the Port of NY/NJ. Red Hook Terminals has taken hold of the yard tractors and is decommissioning the old diesel equipment and finalizing the closeout paperwork.

### Best Transportation

DEP awarded \$1,189,000 to Best Transportation to purchase 4 electric yard tractors and charging stations which will operate in the Newark, Jersey City area of NJ. Best Transportation was only able to move this project forward by replacing and purchasing 2 electric yard tractors. The total award of VW funds was reduced to \$566,797,50. This project is almost complete. Unused funds will be returned to the VW Trustee.

### eCHE

DEP awarded a total of \$14,796,598 to 12 different companies. All pieces of equipment will operation in overburdened communities.

## Mitigation Action 9

### It Pay\$ to Plug In

This semi-annual report documents the progress and implementation for installing electric vehicle supply equipment throughout the State of New Jersey. The first draw down from the Volkswagen Mitigation Trust allocates \$3.2 million to allow DEP to award grants through the It Pay\$ to Plug In – New Jersey’s Electric Vehicle Charging Grant Program. This will allow New Jersey to more than double the number of non-residential charging ports in the state. To date, New Jersey has been able to approve \$3,209,000 in grant packages, that will allow for 837 ports at 231 locations.

This semi-annual report also documents the second draw down from the Volkswagen Mitigation Trust, which allocates \$7,621,000 for the installation of electric vehicle supply equipment. The primary focus of this allocation will be on Direct Current Fast Charger (DCFC) supply equipment. To date, New Jersey has awarded \$5,000,000 in grant packages that will allow for 50 DCFC ports at 25 locations.

### Summary of Activities

- Response to the SARS-CoV-2 pandemic has either delayed or postponed projects that were supposed to begin by the end of 2020. Those changes have been reflected in this report.
- 24 projects were either canceled, withdrawn, or reassigned to other funding sources. The DEP was able to replace those projects in kind.
- 52 projects have been completed through reimbursement during this period.

- The NJDEP used the same outreach materials for this project as we have been using for other It Pay\$ to Plug In funding rounds.
