# Description of Status (include actual or projected termination date):

- Completion date of Round Four is scheduled for 12/30/22.
- The buses are being manufactured now and we are obtaining monthly status updates from Ross Transportation.
- EV charging station equipment for Newcastle and Kingston has been ordered and we are obtaining regular status updates from Preferred Service CNG, LLC. Quotes pending for medical center charging stations.
- To date, \$17,519.82 has been spent on staff supplies and everything has been received except the Zoom Room equipment. Zoom room equipment ordered 4/20/22.

## Development (planning work accomplished for the project):

- Purchasing of the buses is complete.
- Purchasing of charging stations for Newcastle and Kingston is complete.
- Project scoping and implementation was completed for the installation of the chargers.
- Two charging stations for medical center remain and quotes are in progress. Purchase will be completed by next quarter.

#### Implementation (purchases, construction/installation of infrastructure, etc.):

The following equipment has been purchased: Bus EV Charger for Newcastle-4/21/22, Bus EV Charger for Kingston -4/22/22, Two Buses -4/11/22.

The electric buses have not been received to date but are ordered with an anticipated arrival date of 05/01/23 due to supply chain delays.

Administration funds were received and \$25,618.81 expensed before May 1, 2022. Purchases include salaries, fuel, vehicle maintenance, zoom room and office equipment, and office supplies.
