The two mitigation actions are almost complete. Final procurement of T-800 Kenworth Truck (Fisheries) and Ford F550 Transit Bus (Enterprises) was completed this reporting period. Semi-annual reporting has been delayed due to disruptions and complications resulting from the COVID-19 Pandemic. Obligations projected to be completed next reporting period.

Development (planning work accomplished for the project):

Inter-program coordination and planning continued for implementation of mitigation actions, processing of paperwork, and recordkeeping.

Implementation (purchases, construction/installation of infrastructure, etc.):

Both mitigation action vehicles were procured this reporting period.

2021 T-800 Kenworth Truck: Mitigation Funds=\$111,090
