Dear Wilmington Trust, N.A.:

The Texas Commission on Environmental Quality (TCEQ), Lead Agency for administering the funds allocated to Texas under the Volkswagen State Environmental Trust (Trust), provides this semi-annual report to Wilmington Trust, N.A. (Trustee) in accordance with Section 5.3 of the Environmental Mitigation Trust Agreement for State Beneficiaries (Trust Agreement).

On March 24, 2020, Texas issued the first disbursement of trust assets which initiates the requirement for the semi-annual report. TCEQ's first semi-annual report includes steps taken to implement all approved Texas Volkswagen Environmental Mitigation Program (TxVEMP) Eligible Mitigation Actions for the period beginning May 8, 2019 and ending June 30, 2020.

## I. Status of Approved Eligible Mitigation Actions

The status of each approved Eligible Mitigation Action is provided below. A summary of projects awarded under the approved Eligible Mitigation Actions is provided as **Attachment A**.

#### Class 4 - 8 School Buses, Shuttle Buses, and Transit Buses

TCEQ filed an Eligible Mitigation Action Certification Form with the Trustee on March 24, 2019 to request \$60,998,888 in funding to implement a grant round for Class 4-8 school buses, shuttle buses, and transit buses. TCEQ included in the request \$58,652,777 in project expenditures and \$2,346,111 in administrative expenditures. The Trustee approved the request on May 6, 2019.

On May 8, 2019, TCEQ issued a <u>Request for Grant Applications (RFGA)</u> with \$58,652,777 in total funding for projects to repower or replace Class 4-8 school buses, shuttle buses, and transit buses.

TCEQ awarded over \$56 million for 83 projects on a first-come, first-served basis. Projects awarded include the repower or replacement of 722 buses totaling over 428 tons of mitigated nitrogen oxides (NOX) emissions. TCEQ subsequently issued grant agreements for the 83 projects selected for award under this round of funding. TCEQ closed this round of funding on May 8, 2020.

#### Class 7 - 8 Refuse Vehicles

As proposed in the Beneficiary Mitigation Plan for Texas, TCEQ implemented a separate grant round for Class 7-8 refuse vehicles under the Eligible Mitigation Actions for Class 4-7 Local Freight Trucks and Class 8 Local Freight and Port Drayage Trucks categories.

On August 26, 2019, TCEQ filed two Eligible Mitigation Action Certification Forms with the Trustee requesting a total of \$43,570,635 in funding to implement a grant round for Class 7-8 refuse vehicles. TCEQ included in each request \$20,947,420.50 in project expenditures and \$837,897 in administrative expenditures. The Trustee approved the requests on October 2, 2019.

On October 8, 2019, TCEQ issued a <u>RFGA</u> with \$40,994,841 in funding available for projects to repower or replace Class 7-8 refuse vehicles. The total funding under this grant round includes \$20,947,420.50 for Class 7 refuse vehicles and \$20,947,420.50 for Class 8 refuse vehicles. Eligible refuse vehicles include garbage trucks, recycling trucks, roll-off trucks, sweeper trucks, dump trucks, grapple trucks, and chipper trucks. TCEQ plans to accept applications under this round of funding until October 8, 2020.

To date, TCEQ has awarded over \$6 million for 32 projects on a first-come, first-served basis. The projects awarded include the repower or replacement of 111 refuse vehicles totaling over 134 tons of mitigated  $NO_x$  emissions. TCEQ is currently in the process of issuing and executing additional grant agreements for projects selected for award under this round of funding.

## Class 4 - 7 Local Freight Trucks & Class 8 Local Freight Trucks and Port Drayage Trucks

TCEQ filed two Eligible Mitigation Action Certification Forms with the Trustee on December 5, 2019 to request a total of \$34,856,507.92 in funding to implement a grant round for Class 4-7 local freight trucks and Class 8 local freight and port drayage trucks. TCEQ included in each request \$16,757,936.50 in project expenditures and \$670,317.46 in administrative expenditures. The Trustee approved the requests on January 31, 2020.

On February 6, 2020, TCEQ issued a RFGA with \$33,515,873 in total funding for projects to repower or replace Class 4-7 local freight trucks and Class 8 local freight trucks and port drayage trucks. The total funding under this grant round includes \$16,757,936.50 for Class 4-7 local freight trucks and \$16,757,936.50 for Class 8 local freight trucks and port drayage trucks. TCEQ plans to accept applications under this round of funding until January 27, 2021.

To date, TCEQ has awarded over \$6 million for 43 projects on a first-come, first-served basis. The projects awarded include the repower or replacement of 214 freight and port drayage trucks and over 425 tons of mitigated  $NO_X$  emissions. TCEQ is currently in the process of issuing and executing additional grant agreements for projects selected for award under this round of funding.

### Light-Duty Zero Emission Vehicle (ZEV) Supply Equipment

The TCEQ filed an Eligible Mitigation Action Certification Form with the Trustee on May 4, 2020 to request \$32,653,788.96 in funding to implement two grant rounds for light-duty ZEV supply equipment. TCEQ included in the request \$31,397,874 in project expenditures and \$1,255,914.96 in administrative expenditures. The Trustee approved the request on June 30, 2020.

TCEQ has scheduled the opening of the first grant ground in Fall of 2020. TCEQ will offer approximately \$10.5 million in funding statewide on a first-come, first-served basis for the

purchase and installation of Level 2 charging equipment for light-duty zero emission vehicles in public areas, workplaces, and multi-unit residences.

TCEQ intends to offer a second grant round in the Spring of 2021. In the second grant round, TCEQ will offer approximately \$20.9 million in funding statewide on a competitive basis for the purchase and installation of direct current fast charging and hydrogen fuel cell infrastructure in public areas, workplaces, and multi-unit residences. TCEQ plans to accept applications under this round of funding for 90 days. Once the round has closed, projects will be scored and ranked based on ability to meet program goals.

## II. Summary of Expenditures for Approved Eligible Mitigation Actions

TCEQ will issue payments for project expenditures on a reimbursement basis for eligible expenses incurred and paid by the grant recipient. The TCEQ will authorize reimbursement amounts in accordance with predetermined maximum funding amounts established by the TCEQ for that type of activity. This amount may be adjusted downward in accordance with the maximum percentage of cost limits established in the Trust Agreement and Beneficiary Mitigation Plan for Texas. Reimbursement will be disbursed via check issued by Wilmington Trust, N.A., as directed by TCEQ.

A summary of project and administrative expenditures for each approved Eligible Mitigation Action is provided as **Attachment B**.

## III. Future Implementation of Eligible Mitigation Actions

A tentative schedule for the implementation of the remaining Eligible Mitigation Actions is provided below. Progress on the implementation of these Mitigation Action Categories will be provided in future reports.
