Due to the COVID-19 crisis, most of the awardees were impacted in various ways. Timelines were affected significantly, and projects have moved slower than anticipated. All projects selected for actions 1,2,6,7, and 8, are electrification projects which replace diesel equipment with electric and will operate in disadvantaged communities.

Mitigation Action 1

Regional Industries – Electric Garbage Trucks

DEP awarded \$1,717,000 to Regional Industries to purchase 5 battery electric garbage trucks to be operated in Elizabeth, NJ. Unfortunately, Regional will not be moving forward with this project. The electric garbage trucks available at this time do not meet their operational needs. This project is being terminated and funds will be returned to the Trustee.

International Motor Freight/IKEA

DEP awarded \$262,500 to International Motor Freight/IKEA to purchase 1 all electric drayage truck to be operated and domiciled at Port Newark, NJ. IMF has obtained price quotes and is finalizing grant paperwork.

Hudson County Motors

DEP awarded \$1,167,000 to Hudson County Motors to purchase 4 all electric drayage trucks to operate in Hudson and Essex Counties. Hudson County Motors is unable to find a partner that has old enough trucks which meets the eligibility requirement of the consent decree. This project is being terminated and funds will be returned to the Trustee.

Mitigation Action 2

NJ Transit Electric Buses – Camden

DEP awarded \$8 million to NJ Transit to purchase 8 electric transit buses to be operated in Camden, NJ. NJ Transit issued a RFP for electric bus procurement. Delivery of buses is expected in the fall of 2021.

Student Transportation of America

DEP awarded \$1,975,000 to Student Transportation of America to purchase 5 electric school buses and charging stations which will be operated in Trenton, NJ. Student Transportation of America has ordered the electric school buses and is in the planning stages of the electric vehicle charging infrastructure.

Mitigation Action 6

City of Jersey City

DEP awarded \$2,046,000 to the City of Jersey City to purchase 5 electric garbage trucks and charging stations which will operate throughout Jersey City, NJ. The electric garbage trucks were recently delivered. The old diesel garbage trucks will be decommissioned, and this project will be completed in the next couple of months.

<u>IKEA</u>

DEP awarded IKEA Distribution Services of North America \$825,000 to purchase 5 electric box trucks and charging stations which will operate in Cherry Hill, Camden, Jersey City and Hoboken. IKEA is awaiting price quotes from various manufacturers.

Mitigation Action 7

United Airlines

DEP awarded United Airlines \$2,566,529 to purchase 39 piece of electric ground support equipment. DEP also awarded the Port Authority of NY/NJ \$1,000,000 for the electric charging infrastructure to be installed at Newark Liberty International Airport. Port Authority of NY/NJ are obtaining prices quotes based on engineering studies for the installation of the charging stations. United Airlines had to withdraw their proposal. The effects of COVID on the airline industry is preventing this project from moving forward. The United Airlines project is being terminated and funds will be returned to the Trustee. Port Authority is looking to partner with another airline.

Mitigation Action 8

Red Hook Terminals

DEP awarded \$2,467,000 to Red Hook Terminals to purchase 10 electric yard tractors and charging stations in the Port of NY/NJ. Red Hook Terminals is expecting delivery of the yard tractors within the next month.

<u>IKEA</u>

DEP awarded IKEA Distribution Services of North America \$960,000 to purchase 4 electric yard tractors and charging stations. The yard tractors are ordered and will be delivered in 6 months.

Best Transportation

DEP awarded \$1,189,000 to Best Transportation to purchase 4 electric yard tractors and charging stations which will operate in the Newark, Jersey City area of NJ. Best Transportation has ordered the yard tractors and expect delivery in about 6 months.

Mitigation Action 9

It Pay\$ to Plug In

This semi-annual report documents the progress and implementation for installing electric vehicle supply equipment throughout the State of New Jersey. The first draw down from the Volkswagen Mitigation Trust allocates \$3.2 million to allow DEP to award grants through the It Pay\$ to Plug In – New Jersey's Electric Vehicle Charging Grant Program. This will allow New Jersey to more than double the number of non-residential charging ports in the state. To date, New Jersey has been able to approve \$2,957,419 in grant packages, that will allow for 751 ports at 183 locations. This is \$251,580 less than the last reporting period due to the number of projects that have withdrawn. However, there are enough projects in-house on the waitlist, that all the funds will be obligated during the next reporting period.

Summary of Activities

- Response to the SARS-CoV-2 pandemic has either delayed or postponed projects that were supposed to begin by the end of 2020. Those changes have been reflected in this report.
- 28 projects were either canceled or withdrawn. The DEP was able to replace those projects in kind, however more projects will have to be taken from the waitlist to completely obligate all of the VW monies.
- 3 projects have been completed through reimbursement and 21 projects have entered the reimbursement phase during this period.
- Some minor modifications were made to application materials, and the grant award packages. Updated documents are located at https://www.state.nj.us/dep/vw/.

- The NJDEP used the same outreach materials for this project as we have been using for other It Pay\$ to Plug In funding rounds.
