#### Explanation of how funding request fits into Beneficiary's Mitigation Plan (5.2.1):

Ohio's BMP filed May 31, 2018 allocates \$19 million to the replacement or repower of non-road/off-road diesel fleets and equipment, including specifically \$12,000,000 for large industrial forklifts and port cargo handling equipment. This request will support 12 projects to replace diesel port cargo handling equipment with all-electric equipment. Ten of these projects are being carried out in Cuyahoga, Delaware, Franklin, Lucas, Portage and Summit Counties, all designated as first priority for funding in Ohio's BMP because of population density, historical levels of diesel emissions and nonattainment of national ozone standards under the Clean Air Act. The other two projects are located in Trumbull County, designated as second priority for funding in Ohio's BMP because of population density, historical levels of diesel emissions, and ongoing struggles to maintain attainment with national ozone standards under the Clean Air Act. This request is for \$7,820,826 in Trust funds: \$7,309,183 to support twelve repower or replacement projects, and \$511,642.81 (7%) for Ohio EPA's administrative costs to oversee these projects. Ohio's Beneficiary Mitigation Plan estimates Ohio EPA's total administrative costs at \$5.05 million, or 7% of the state's total allocation.

#### Detailed Description of Mitigation Action Item Including Community and Air Quality Benefits (5.2.2):

Twenty-two diesel terminal tractors, 1 heavy duty diesel forklift and six diesel material handler cranes will be replaced with all-electric equipment at sites in Ohio ports and eligible intermodal distribution centers. Ohio EPA used US EPA's Diesel Emission Quantifier (DEQ) tool to estimate annual emission reduction benefits to be achieved by the twelve projects to be: 28.258 tons of NOx, 2.913 tons of fine particulates (PM<sub>2.5</sub>), 2.23 tons of hydrocarbons, and 13.377 tons of carbon monoxide. The list of projects follows, and a table with emission reduction estimates for each project is included in the next section on page 3.

to provide at least 25% of the replacement or repower costs. Actual percentages for each project are included in the Project Budget table on page 7 within Attachment B below.

Describe how the Beneficiary complied with subparagraph 4.2.8, related to notice to U.S. Government Agencies (5.2.9):

On February 23, 2018, Ohio EPA provided notice, via letter and email, of availability of Mitigation Action Funds to all the parties named in 4.2.8, as well as the Wright-Patterson Air Force Base (WPAFB) Civil Engineer Group, the WPAFB Environmental Branch, both in Dayton, and the U.S. Army Corps of Engineers Great Lakes and Ohio River Division in Cincinnati. Notification to the U.S. Forest Service was copied to the Wayne National Forest headquarters in Nelsonville, Ohio. The notice included a summary description of the Volkswagen Settlement including links to Appendix D-2 and Ohio's at-that-time Draft Beneficiary Mitigation Plan with a listing of Eligible Mitigation Actions, an explanation of how Ohio EPA would evaluate grant applications, and instructions to sign up for notification about implementation of Ohio's BMP, funding opportunities and application guidelines for the program in Ohio.

This program will reduce emission exposures of children and adults living and working in and around ports and eligible intermodal distribution centers in Cuyahoga, Delaware, Franklin, Lucas, Portage, Summit and Trumbull Counties. Six of these counties have been designated as first priority for receiving Environmental Mitigation Funds, and Trumbull County has been designated as second priority, based on the following considerations:

- air quality (Ohio counties of concern due to nonattainment of national air quality standards for ozone and PM<sub>2.5</sub>);
- historical levels of diesel emissions;
- the location of concentrated sources of air pollution such as distribution centers, multimodal centers, ports, rail and bus terminals and airports;
- the counties where the most VW vehicles equipped with defeat devices were registered in Ohio;

- county overlays using U.S. EPA's *EJScreen: Environmental Justice Screening and Mapping Tool*.
