Due to the COVID-19 crisis, most of the awardees were impacted in various ways. Timelines were affected significantly, and projects have moved slower than anticipated. There have been significant price increases and supply chain issues that are affecting the timeliness of projects.

Grant Process – Project is moving forward, and grant paperwork is being finalized.

Project in process – Project funds have been encumbered and vehicles have been ordered.

Mitigation Action 9

It Pay\$ to Plug In

This semi-annual report documents the progress and implementation for installing electric vehicle supply equipment throughout the State of New Jersey. The first draw down from the Volkswagen Mitigation Trust allocates \$3,209,000 to allow DEP to award grants through the It Pay\$ to Plug In – New Jersey's Electric Vehicle Charging Grant Program. This will allow New Jersey to more than double the number of non-residential charging ports in the state. To date, New Jersey has been able to approve \$2,767,233 in grant packages, that will allow for 797 ports at 204 locations.

This semi-annual report also documents the second drawdown from the Volkswagen Mitigation Trust, which allocates \$7,621,000 for the installation of electric vehicle supply equipment. The primary focus of this allocation will be on Direct Current Fast Charger (DCFC) supply equipment. To date, New Jersey has awarded \$5,600,000 in grant packages that will allow for 88 DCFC ports at 35 locations.

Summary of Activities

- Response to the SARS-CoV-2 pandemic has either delayed or postponed projects that were supposed to begin by the end of 2020. Those changes have been reflected in this report.
- 13 projects were either canceled, withdrawn, or reassigned to other funding sources. The DEP was able to replace those projects in kind, plus more for a total of 27 new projects this period.
- 1 project has been completed through reimbursement during this period.
- Some minor modifications were made to application materials, and the grant award packages. Updated documents are located at https://www.state.nj.us/dep/vw/.
- The web site has been updated to reflect funding requests, and the number of project proposals that have been received by NJDEP. Project proposal request forms have also been updated. All documents are located at https://www.state.nj.us/dep/vw/.
- The NJDEP used the same outreach materials for this project as we have been using for other It Pay\$ to Plug In funding rounds.
