<b>Explanation of how funding request fits into Beneficiary's Mitigation Plan (5.2.1):</b> Missouri's BMP allocates \$6 million government-owned truck repowers and replacements. Missouri's plan also acknowledges and complies with the state's legislative appropriations process. In state fiscal year 2021, the department will facilitate a payment up to \$1 million in VW Trust Funds to the Missouri Department of Corrections (DOC) to implement eligible mitigation actions pursuant to the VW Trust agreement. The mitigation action DOC is implementing through this funding request falls under Missouri's Award Category 2, Government Trucks. This funding request will count towards the total funding amount dedicated to Award Category 2 in the BMP.			
<b>Detailed Description of Mitigation Action Item Including Community and Air Quality Benefits (5.2.2):</b> Diesel-to-diesel replacements reduce NO <sub>x</sub> emissions and have a co-benefit of reducing particulate matter. This project supports the upgrading of the state-owned fleet. This project will reduce local diesel emissions exposure, while also decreasing regionally transported NO <sub>x</sub> pollution that contributes to the formation of ground-level ozone pollution.			
<b>Estimate of Anticipated NO<sub>x</sub> Reductions (5.2.3):</b> Missouri has used the EPA's Diesel Emissions Quantifier to calculate the emission reductions this project will achieve. The results are below.

As allowed by the VW Trust, beneficiaries may use VW Trust funds to cover up to 100 percent of the cost of a replacement for an eligible government-owned medium truck.			
<b>Describe how the Beneficiary complied with subparagraph 4.2.8, related to notice to U.S. Government Agencies (5.2.9).</b> On February 28, 2018, the Department notified the Department of Interior, including the National Park Service and U.S. Fish and Wildlife Service, and the Department of Agriculture, including the Forest Service of the availability of VW funds for locations within Missouri. The Department did not receive notice from any other federal agency indicating interest in these funds.			
<b>If applicable, describe how the mitigation action will mitigate the impacts of NO<sub>x</sub> emissions on communities that have historically borne a disproportionate share of the adverse impacts of such emissions (5.2.10).</b> The trucks DOC is replacing through this funding request operate on highways including high traffic areas along with numerous other mobile emission sources, meaning these areas bear a disproportionate share of the air pollution burden.			


