Explanation of how funding request fits into Beneficiary's Mitigation Plan (5.2.1): Illinois' revised BMP submitted in April 2022 allocates up to 19 percent of its funds to replace older diesel local freight trucks with new all-electric local freight trucks and charging infrastructure and up to 2 percent for administrative costs (Section IV(D)).	
Detailed Description of Mitigation Action Item Including Community and Air Quality Benefits (5.2.2): This funding request involves the replacement of seven Class 8 engine model year 2002-2009 local freight/delivery trucks with seven new Class 8 all-electric freight/delivery trucks. The seven new trucks will operate in the Chicago nonattainment area (Priority Area 1 in Illinois' BMP) and serve the City of Darien, Village of Oak Park, and the City of Chicago. The grant award was established at 75% of eligible costs for the electric freight/delivery trucks. The grant award for the City of Darien for one truck is \$447,591.75, for the RTA and five trucks is \$2,407,277.75 and the Village of Oak Park for one truck is \$310,125. The total funding for these three projects is \$3,164,994.50. Replacing seven older diesel trucks with new electric trucks will result in reductions of NOx and other pollutants thereby providing air quality benefits in the Chicago area.	
Estimate of Anticipated NOx Reductions (5.2.3): It is anticipated that the projects will result in 0.72 tons of annual NOx reductions.

Describe any cost share requirement to be placed on each NOx source proposed to be mitigated (5.2.8):

Environmental Mitigation Trust Funds will provide 75% funding of eligible costs for the two new electric trucks. Applicants are required to provide a minimum 25% cost share, resulting in a total minimum cost share amount of \$201,625 for the two projects.

Describe how the Beneficiary complied with subparagraph 4.2.8, related to notice to U.S. Government Agencies (5.2.9):

Illinois EPA provided the requisite notice via email to the appropriate agencies on February 27, 2018.

If applicable, describe how the mitigation action will mitigate the impacts of NOx emissions on communities that have historically borne a disproportionate share of the adverse impacts of such emissions (5.2.10):

The two new electric trucks will operate in the Chicago ozone nonattainment area and will serve the Village of Oswego and the City of Aurora. The trucks will serve and operate in areas that have a large, disproportionate amount of diesel truck traffic and related emissions. These projects will reduce emission impacts in the overall Chicago nonattainment area and in the communities served.


