<b>Explanation of how funding request fits into Beneficiary's Mitigation Plan (5.2.1):</b> Illinois' revised BMP submitted in April 2022 allocates up to 19 percent of its funds to replace older diesel local freight trucks with new all-electric local freight trucks and charging infrastructure and up to 2 percent for administrative costs (Section IV(D)).	
<b>Detailed Description of Mitigation Action Item Including Community and Air Quality Benefits (5.2.2):</b> This funding request involves the replacement of one Class 4 engine model year 2002 and one Class 7 engine model year 2007 local freight/delivery trucks with one new Class 4 and one new Class 7 all-electric freight/delivery trucks. The two new trucks will operate in the Chicago nonattainment area (Priority Area 1 in Illinois' BMP) and serve the Village of Oswego and the City of Aurora.  The grant award was established at 75% of eligible costs for the electric freight/delivery trucks. The grant award for the Village of Oswego for one truck is \$457,500, and for the City of Aurora for one truck is \$147,375. The total funding for both projects is \$604,875. Replacing two older diesel trucks with new electric trucks will result in reductions of NOx and other pollutants thereby providing air quality benefits in the Chicago area.	
<b>Estimate of Anticipated NOx Reductions (5.2.3):</b> It is anticipated that the projects will result in 0.32 tons of annual NOx reductions.

Applicants are required to provide a minimum 25% cost share, resulting in a total minimum cost share amount of \$1,054,998 for the three projects.</p>
<p><b>Describe how the Beneficiary complied with subparagraph 4.2.8, related to notice to U.S. Government Agencies (5.2.9):</b></p> <p>Illinois EPA provided the requisite notice via email to the appropriate agencies on February 27, 2018.</p>
<p><b>If applicable, describe how the mitigation action will mitigate the impacts of NOx emissions on communities that have historically borne a disproportionate share of the adverse impacts of such emissions (5.2.10):</b></p> <p>The seven new electric trucks will operate in the Chicago ozone nonattainment area and will serve the City of Darien, Village of Oak Park, and City of Chicago. The trucks will serve and operate in areas that have a large, disproportionate amount of diesel truck traffic and related emissions. These projects will reduce emission impacts in the overall Chicago nonattainment area and in the communities served.</p>
