Explanation of how funding request fits into Beneficiary's Mitigation Plan (5.2.1):	
Illinois' revised BMP submitted in April 2022 allocates up to 19 percent of its funds to replace older diesel local freight trucks with new all-electric local freight trucks and charging infrastructure and up to 2 percent for administrative costs (Section IV(D)).	
Detailed Description of Mitigation Action Item Including Community and Air Quality Benefits (5.2.2):	
This funding request involves the replacement of two Class 8 engine model year 1998 and 2007 local freight/delivery trucks with two new Class 8 all-electric freight/delivery trucks. The new trucks will operate in the Joliet area in Will County (Priority Area 1 in Illinois' BMP) and will be transporting and delivering freight and supplies between warehouse districts and similar locations.	
The grant award was established at 50% of eligible costs for electric freight/delivery trucks. The grant award for Kutzler YMX MC for two trucks is \$371,924. Replacing older diesel trucks with new electric trucks will result in reductions of NOx and other pollutants thereby providing air quality benefits in the Joliet area.	
Estimate of Anticipated NOx Reductions (5.2.3):	
It is anticipated that the project will result in 1.1 tons of annual NOx reductions by scrapping two older Class 8 trucks making local deliveries that average nearly 30,000 miles and consume 6,000 gallons of diesel fuel annually.

Describe any cost share requirement to be placed on each NOx source proposed to be mitigated (5.2.8):

Environmental Mitigation Trust Funds will provide 50% funding of eligible costs for the new electric trucks. Applicants are required to provide a minimum 50% cost share, resulting in a total minimum cost share amount of \$371,924 for the project.

Describe how the Beneficiary complied with subparagraph 4.2.8, related to notice to U.S. Government Agencies (5.2.9):

Illinois EPA provided the requisite notice via email to the appropriate agencies on February 27, 2018.

If applicable, describe how the mitigation action will mitigate the impacts of NOx emissions on communities that have historically borne a disproportionate share of the adverse impacts of such emissions (5.2.10):

The new electric trucks will operate in the Joliet area in Will County and will operate in low-income areas adjacent to several warehouse districts in transporting freight and supplies. The new trucks will be zero emissions and eliminate idling emissions that were an issue for the older trucks. The trucks will operate in areas that have a large, disproportionate amount of diesel truck traffic and related emissions.
